THE TRIPURA TRIBAL AREAS AUTONOMOUS DISTRICT VILLAGE COMMITTEE (DELIMITATION OF CONSTITUENCIES) RULES, 1994.

In exercise of the powers conferred by sub-section (2) of Section 40 of the Tripura Tribal Areas Autonomous District (Establishment of Village Committee) Act, 1994, the Executive Committee hereby makes the following Rules to regulate Delimitation of Constituencies and all other matters relating thereto under the said Act :-

1. Short title & Commencement :-

- (1) These rules may be called the Tripura Tribal Areas Autonomous District Village Committee (Delimitation of Constituencies) Rules, 1994.
- (2) They shall come into force on and from the date of their publication in the Tripura Gazette.

2. Definition :-

- (1) In these Rules, unless there is anything repugnant to the subject or the context—
 - (a) “Act ” means the Tripura Tribal Areas Autonomous District (Establishment of Village Committee) Act, 1994,
 - (b) “Form ” means a form appended to these Rules and includes a manuscript or typewritten or cyclostyle copy and also Bengali translated copy thereof.
 - (c) “Section ” means a Section of the Act;
- (2) The expressions used in these Rules and not otherwise defined shall have the same meaning as are respectively assigned to them in the Act.

3. Delimitation of number of members of a Village Committee :-

- (1) Subject to the maximum and minimum number laid down in sub-section (1) of Section 4, the Sub-Divisional Magistrate shall, by notification in Form “A” determine the number of members to be elected to a Village Committee as far as practicable on the following scale :-

<u>Population</u>	<u>Number of members</u>
*a) Where the population of a village does not exceed 2500 (Two thousand five hundred)	7 (Seven)
*b) Where the population of a village exceeds 2500 (Two thousand five hundred)	9 (Nine)
*c) Where the population of a village exceeds 4000 (Four thousand)	11 (Eleven)

(2) The *Sub-Divisional Magistrate shall, out of the number of members determine under sub-rule (1) reserve seat or seats if any, as required under Section 4.

***4. Division of a village into constituencies and allocation of seats to constituencies :-** Subject to the maximum and minimum number laid down in sub-section (1) of Section 4, the Sub-Divisional Magistrate shall, by notification in Form B, determine –

- a) the name and number of the constituencies into which the area of a village shall be divided.
- b) the area to be include in each constituencies relating to a village shall, as far as practicable, be geographically compact area;

Provided further that every constituency shall be so delineated as to fall wholly within the area of the village;

- c) the number of seat or seats to be allocated to each constituency;

Provided that the number of members to be allotted to each constituency shall as far as practicable be in the same proportion to the total number of members to be allocated for the Village Committee as the population of that constituency bears to the total population of the village;

- d) the number of seat or seats, if any, reserved as referred to in sub-rule (2) of Rule 3.

***5. Manner of publication of the Notification under Rule 3 & 4 :-**

The Notification in Form "A" under Rule 3 shall be published by posting up copies thereof in some conspicuous places in the office of the

- * (a) the Sub-Divisional Magistrate ;
- (b) the Block Development Officer and
- (c) the Village Committee to which the Notification relates ;

Provided that the Notification as aforesaid shall be deemed to have been duly published if there has been substantial compliance with the provision of this Rule and any inadvertent omission to the post up the notification in one or more places shall not invalidate the notifications. Any objection/suggestion regarding the draft publication as per Form A shall be taken up for consideration after one week from this day which may be received by the S.D.M.

*The S.D.M. shall, by an order in Form "A-1" after hearing objections/ suggestion if any shall publish total number of seats in each Village Committee and this shall be final.

***6.** The Notification in Form B under Rule 3 shall be published by posting up copies thereof in some conspicuous places in the office of -

- * (a) the Sub-Divisional Magistrate ;
- (b) the Block Development Officer; and
- (c) the Village Committee to which the notification relates ;

Provided that the Notification as aforesaid shall be deemed to have been duly published if there has been substantial compliance with the provision of this Rule and any inadvertent omission to post up the notification in one or more places shall not invalidate the notifications. Any objection/suggestion regarding the draft publication as per Form B shall be taken up for consideration after one week from the day which may be received by the *S.D.M.

The S.D.M. shall, by an order in Form "B-1" after hearing objections/ suggestion if any shall determined the name & number of constituencies into which the area of a Village shall be divided specifying the area to be included in each constituency and this shall be final.

Provided also if the Executive Committee makes any order under sub-section (3) of Section 4 or Section 5, modifying the Notification issued in Form "A-1" or Form "B-1" the *Sub-Divisional Magistrate shall issue fresh Notification in Form "A" or as the case may be in Form "B" incorporating the same modification and publish the same in manner specified hereinabove and thereupon such fresh modification in Form "A-1" or as the case may be in Form "B-1" shall be final.
