
NOTIFICATION

In exercise of the powers conferred by the Section-135B of the Representation of the People Act, 1951, the Governor, Tripura is pleased to declare that all the Government offices/Magisterial Courts/Educational Institution/Financial Institutions and all other establishments in the State of Tripura shall remain closed on **24th February, 2016 (Wednesday)** throughout the State in order to make it convenient for voters to exercise their right of franchise during the ensuing General Election to TTAAD Village Committee, 2016.

2. It will also be a paid holiday on 24th February, 2016 (Wednesday) for the employees of the Industrial undertakings of the Government of Tripura coming under the purview of the Factories Act.1948, and daily rated/Contingent Employees under the Government of Tripura and workers/employees in any business/trade in Tripura to exercise their right of Franchise on the poll day.

3. This shall not apply to any elector whose absence may cause danger or substantial loss in respect of the employment in which he/she is engaged.


