NOTIFICATION

In exercise of the powers conferred by the Section-25 of the Negotiable Instruments Act, 1881 (XXVI of 1881) the Governor, Tripura is pleased to declare that all the Government offices/Magisterial Courts/Educational Institutions and Financial Institutions in the State of Tripura shall remain closed on 9th December, 2015 (Wednesday) throughout the State in order to make it convenient for voters to exercise their right of franchise during the ensuing General Election to Municipalities and Bye-Election of Panchayats, 2015.

It will also be a paid holiday on 9th December, 2015 (Wednesday) for the employees of the Industrial undertakings of the Government of Tripura coming under the purview of the Factories Act, 1948, and daily rated/contingent employees under the Government of Tripura and workers/employees in any business/trade in Tripura to exercise their right of franchise on the poll day.
