NOTIFICATION

The following Rules which have been made by the Executive Committee of the Tripura Tribal Areas Autonomous District Council, are hereby published in the Tripura Gazette for information,-

Tripura Tribal Areas Autonomous District Village Committee (Preparation of Electoral Roll) Rules, 1996.

In exercise of the powers conferred by the sub-section (2) of Section 40 of the Tripura Tribal Areas Autonomous District (Establishment of Village Committee) Act, 1994, the Executive Committee hereby makes the following Rules to regulate preparation and publication of Electoral Rolls under the said Act and all other matters relating thereto, namely:-

1. Short title and commencement:-

- (1) These Rules may be called the Tripura Tribal Areas Autonomous District Village Committee (Preparation of Electoral Roll) Rules, 1996.
- (2) They shall come into force on and from the date of their publication in the Gazette.

2. Definition:

- (1) In this Rules, unless there is anything repugnant in the subject or the context:
 - (i) "Act" means the Tripura Tribal Areas Autonomous District (Establishment of Village Committee) Act, 1994.
 - (ii) "Council" means the Tripura Tribal Areas Autonomous District Council.
 - (iii) "Constituency" means a Constituency provided under these Rules for the purpose of election to the Village Committee in the Tripura Tribal Areas Autonomous District Council area.
 - (iv) "District Election Officer" means an officer appointed under Rule-4.
 - (v) "Election" includes General Election and by election to fill up a seat or seats in the Village Committee.

- (vi) "Electoral Registration Officer" means the Electoral Registration Officer of a Constituency appointed under Rule-5 and includes an Asst. Electoral Registration Officer thereof appointed under Rule-6;
- (vii) "Executive Committee" means the Executive Committee of the Tripura Tribal Areas Autonomous District Council;
- (viii) "Electoral Roll" means the electoral Roll prepared under these Rules for a constituency.
- (ix) "Electoral Roll Number of a person" means-
 - (a) the serial number of the entry in the electoral roll in respect of the person;
 - (b) serial number of the part of the electoral roll in which such entry occurs; and
 - (c) the name and number of the constituency to which the electoral roll relates;
- (x) "Form" means a form appended to these Rules and includes a manuscript or type written or cyclostyled copy and a translated copy thereof in Bengali;
- (xi) "Gazette" means the Tripura Gazette;
- (xii) "Government" means Government of Tripura;
- (xiii) "Order" means an order published in Gazette;
- (xiv) "Section" means a Section of the Tripura Tribal Areas Autonomous District (Establishment of Village Committee) Act, 1994.
- (xv) "State Election Commission" means the State Panchayet Election Commission appointed by the Governor of Tripura under Article 243 K of the Constitution of India read with Section 176 of the Tripura Panchayet Act, 1993.
- (2) The expressions used in these Rules and not otherwise defined shall have the same meaning as respectively assigned to them in the Act.

3. Interpretation in case of doubt :-

The Tripura General Clause Act, 1966 shall apply for the interpretation of these Rules as it applies for the interpretation of Act of the Legislature of the State of Tripura.

4. Appointment of District Election Officer:-

(1) The State Election Commissioner shall in consultation with the Executive Committee and State Government designate or nominate a District Election Officer who shall be an Officer of the Government of Tripura.

Provided that the State Election Commissioner may designate or nominate more than one such officer, if the State Election Commissioner is satisfied that the function of the officer cannot be performed satisfactorily by one officer.

- (2) Subject to the superintendence, direction and control of the State Election Commissioner, the District Election Officer shall coordinate and supervise all works in the District or in the area within his jurisdiction in connection with the preparation of the Electoral Rolls for all Village Committees.
- (3) The District Election Officer shall also perform such other functions as may be assigned to him by the State Election Commissioner.

5. Electoral Registration Officer:-

The Electoral Roll for the Village Committee Constituency shall be prepared by an Electoral Registration Officer who shall be such officer of the Government or of local authority as the State Election Commissioner may, in consultation with the Executive Committee and the State Government designate or nominate in this behalf.

6. Asstt. Electoral Registration Officer:-

- (1) The State Election Commissioner may appoint one or more person as Assistant Electoral Registration Officer to assist any Electoral Registration Officer in the performance of his functions.
- (2) Every Asstt. Electoral Registration Officer shall, subject to the control of the Electoral Registration Officer, be competent to perform all or any of the function of the Electoral Registration Officer.

7. Appoint of person for preparation of Electoral Roll:-

The Executive Committee when so requested by the State Election Commissioner shall make available the services of staff of TTAADC as may be necessary for preparing the Electoral Rolls in respect of any constituency or constituencies of Village Committee.

8. Electoral Rolls :-

For each constituency, there shall be an electoral roll showing the names of the persons qualifi d to vote. Electoral Roll shall be prepared in accordance with the provisions of these Rules under superintendence, direction and control of the State Election Commissioner for Village Committees.

9. Right to vote :-

(1) Except as provided in these Rules, every person whose name is for the time being entered in the electoral roll of any constituency shall be entitled to vote at an election in that Constituency;

Provided that no person shall vote at an election in any constituency, if he—

- (a) has been adjudged by a competent court to be of unsound mind;
- (b) has voluntarily acquired the citizenship of a foreign State, or
- (c) has been sentenced by a Criminal Court for an electoral offence punishable under these Rules or has been disqualified under any law from exercising any other right on account of corrupt practices in connection with an election and six years have not been elapsed from the date of such sentence or disqualification, provided that the disqualification under these clause may, at any time be removed by the Governor if he thinks fit.

10. Notification regarding programme for preparation of electoral roll:-

(1) No person shall vote at an election in more than one constituency notwithstanding that his name may have been registered in the electoral roll for more than one constituency, and if a person votes in more than one constituency, his votes in all such constituencies shall be void.

- (2) No person shall at any election; vote in the same constituency more than once notwithstanding that his name may have been registered in the electoral roll for that constituency more than once and if he does so vote, all his votes in that constituency shall be void.
- (3) No person shall vote at any election if he is confined in prison whether under a sentence of imprisonment or otherwise or is under the lawful custody of the police.
- (4) Every elector shall have the right to cast one vote and no more to any one candidate at an election.

11. Disqualification for registration in the Electoral Roll:-

- (1) A person shall be disqualified for registration in an electoral roll if he:-
 - (a) is not a citizen of India;
 - (b) is unsound mind or insolvent and stands so declared by a Competent Court; or
 - (c) is for the time being disqualified from voting under the provision of any law relating to corrupt practices and other offences in connection with election.
- (2) The name of any person who becomes as disqualified after registration shall forthwith be struck off from the electoral roll in which it is included;

Provided that name of any person struck off from the electoral roll of a constituency by reason of disqualification under clause (c) of sub-rule (1) shall forthwith be reinstated in that roll if such disqualification is, during the period of such roll is in force, removed under any law authorising such removal.

12. No person to be registered in more than one constituency:-

No person shall be registered in the electoral roll for more than one constituency.

13. Conditions of registration:-

Subject to the foregoing provisions of this Rule every person--who--

- (a) is not less than 18 years of age on qualifying date, and
- (b) is ordinarily resident in a constituency of the Village Committee; shall be entitle to be registered in the electoral roll for the constituency.

14. Notification regarding programme for preparation of electoral roll:-

- (1) The State Election Commissioner for Village Committee shall in consultation with the Executive Committee and State Government, draw up the programme for publication of electoral rolls in draft and for final publication of other matter relating to the preparation of electoral rolls.
- (2) The State Election Commissioner shall, in relation to the preparation of electoral roll for any constituency or as the case may be, constituencies of the Village Committee specify, by notification in the Gazette-
 - (a) the date for publication of electoral roll in draft;
 - (b) the last date for filing claims and objections which shall not be earlier than the seventh day of the date of publication of electoral roll in draft under clause (a);
 - (c) the period of disposal of claims and objections; and
 - (d) the date of final publication of the electoral rolls;

Provided that if the State Election Commissioner considers it expedient so to do, for sufficient reasons, extend the period for lodging of claims and objections, period for disposal of such claims and objections and may also make consequential changes with respect to the date for final publication of the electoral rolls.

15. Preparation of electoral rolls and draft publication thereof:-

- (1) Subject to the provisions of these Rules, so much of the electoral rolls of any Assembly constituency or as the case may be, Assembly Constituencies, for the time being in force, as relates to the area comprised within the Autonomous District, shall be the electoral rolls for the election of the members of the Village Committee.
- (2) So much of the electoral rolls for any Assembly Constituency, or as the case may be, Assembly Constituencies for the time being in force, as to the area comprised within a constituency, shall be the electoral rolls for the election of a member of a Village Committee from that constituency.
- (3) The electoral roll for each constituency of the Village Committee shall be prepared by Electoral Registration Officer nominated / designated for that constituency.
- (4) For the purpose of the preparing the electoral roll of each constituency of the Village Committee electoral rolls of any Assembly Constituency or as the case may be, Assembly Constituencies shall be split up in such manner as the Electoral Registration Officer may consider fit, proper and necessary.
- (5) Electoral rolls of each constituency of the Village Committee may be divided into convenient parts which shall be numbered consecutively and shall be prepared in **Form-1** in Bengali or if so directed by the Executive Committee in any other language.

Provided that wherever necessary, the split up rolls referred to in sub-rule (4) may be consolidated and in such event the Serial numbers of the electors be re-numbered so as to ensure consecutive serial numbers of the electors of constituency.

- (6) The Electoral Registration Officer shall publish the roll for a constituency or as the case may be, constituencies of the Village Committee in draft by making a copy thereof available for inspection and displaying the notice in Form-2 & 1A ---
 - (a) at his office and at such places in the constituency as may be specified by him for the purpose, if his office is outside the constituency:

Provided that such electoral rolls may be published in draft either printed or otherwise as may be directed by the State Election Commissioner.

Provided further that such publication of electoral rolls in draft shall be made on the date appointed by the State Election Commissioner for Village Committee under Rule -14.

(7) As soon as the electoral rolls for a constituency are published are published in draft in accordance with the provisions of sub-rule (6) the Electoral Registration Officer shall also give publicity as widely as possible by beat of drum or otherwise within the constituency that the electoral rolls have been published and may be inspected at his office during office hour on all working days and may also state in the notice in Form-2 & 1A and the other places at which the electoral rolls may be inspected:

Provided that if any public holiday intervenes between the date of publication of electoral rolls and the last date for filing claims and objections fixed under Rule-14 the electoral rolls shall be kept ready for inspection by the public even on such public holiday between the hours if 10 A.M. and 5 P.M.

*15.A. Notwithstanding anything contained in the provisions of these Rules the State Election Commissioner may make necessary modification in the Forms prescribed herein, by notification in the official Gazette and on such modification the existing Forms shall be deemed to have been duly amended.

16. Claims and objections :-

- (1) Every claim for the inclusion of a name in the electoral roll shall be—
 - (a) in Form 3; and
 - (b) signed by the person desiring his name to be included in the electoral roll;

Provided that no claim for inclusion of a name in the electoral roll of constituency shall be entertained except on the ground that the name of the person appears as an elector in that part of electoral roll of the Assembly Constituency of the Village Committee.

- (2) Every objection to an entry in the electoral roll shall be:
 - (a) in Form-4 and
 - (b) preferred by a person whose name is already included in that roll:

Provided that no objection for exclusion of any name from the electoral rolls shall be entertained except on the ground that such name has been included in the electoral roll of a constituency of the Village Committee, though such name does not appear in the electoral roll of the Assembly Constituency.

- (3) Every objection ω a particular or particulars in an entry in the electoral roll shall be -
 - (a) in Form-5; and
 - (b) preferred only by the person to whom that entry relates.

17. Manner of lodging claims and objections:-

Every claim or objection shall be presented either to the Electoral Registration Officer or to such other Officer as may be designated by him in this behalf before the last date fixed by the State Election Commissioner under clause (b) of sub-rule (2) of Rule-14:

Provided that any claim or objection which is not lodged within the period or in the form and manner herein specified shall be rejected by the Electoral Registration Officer.

18. Procedure for disposal of claims and objections:-

- (1) Every officer designated under Rule 17, shall forward the claims and objections presented before him to the Electoral Registration Officer with such remarks as he considers proper.
- (2) If the Electoral Registration Officer is satisfied as to the validity of any claim or objection, he may allow it without further inquiry, provided there is no demand in writing for holding an inquiry in the matter.

- (3) Where the claim and objection is not disposed of under sub-rule (2) the Electoral Registration Officer shall fix the place, date and time of hearing of claim and objections and shall give notice of hearing --
 - (a) in the case of claim, to the claimant in Form 6;
 - (b) in the case of an objection to the inclusion of a name, to the objector in Form-7 and to the person objected to in Form-8, and
 - (c) in the case of an objection to a particular or particulars in any entry, to the objector in Form-9.
- (4) Notice under sub-rule (3) may be given either personally or by registered post or by affixing it to the persons residence or last known residence within the constituency.
- (5) On the date fixed for hearing or to which the hearing may be adjourned, the Electoral Registration Officer shall hold a summery inquiry into the claims, or as the case may be objections and after considering any evidence as may be adduced shall pass orders either allowing or disallowing the claims or as the case may be the objections.

Inclusion of names in the electoral rolls inadvertently omitted:-

If it appears to the Electoral Registration Officer that owing to inadvertence or error or otherwise during preparation of electoral rolls, the names of electors appearing in the electoral rolls, for any Assembly Constituency and covered by a Constituency of the Village Committee have been left out of the roll and that remedial actions should be taken under this Rule, the Electoral Registration Officer shall prepare a list of the names and the details of such electors and exhibits a copy of the list together with a notice in his office stating the date on which and time and place at which the inclusion of these names in the electoral roll will be considered. After considering verbal or written objection, if any, the Electoral Registration Officer shall decide whether all or any of the names should be included in the electoral rolls and shall pass order accordingly.

19. Final Publication of Electoral Roll:-

- (1) The Electoral Registration Officer shall thereafter
 - (a) prepare a list of amendment to carry out his decisions under sub-rule (2) and (5) of Rule 18 and under Rule 17 and correct any clerical or printing error of other inaccuracies subsequently discovered in the electoral rolls.
 - (b) published the electoral roll together with the list of amendments, by making a complete copy thereof available for inspection and displaying a notice in Form 10 at his office, and
 - (c) subject to such general or special direction as may be given by the State Election Commissioner for Village Committee, supply free of cost, two copies of the Electoral Rolls as finally published with the list of amendments, if any to every political party for which a symbol has been exclusively reserved by the Election Commissioner of India.

(2) On such publication, the rolls together with the list of amendments shall be the electoral rolls of the constituency.

20. Claims for inclusion of name after final Publication:

- (1) Any person whose name is not included in the electoral rolls of a constituency may apply to the Electoral Registration Officer for inclusion of his name in that roll in Form-3 along with a fee of rupee one provided that no application for inclusion of a name in the electoral roll shall be entertained under this Rule except on the ground that the name of the applicant has not been included in the electoral roll of the constituency of the Village Committee through his name appears as an elector in the related electoral roll of the Assembly Constituency which for the time being is in force.
- (2) The Electoral Registration Officer shall immediately on receipt of such application direct that one copy thereof be posted in some conspicuous places in his office, together with a notice inviting objection to such inclusion within a period of seven days from the such posting.
- (3) The Electoral Registration Officer shall, as soon as may be, after the inquiry of the period specified in sub-rule (2) consider the objections, if any, received by him and shall, if satisfied that the applicant is entitled to be registered as an elector, direct this name to be included therein.
- (4) No amendment by way of inclusion of a name in the electoral roll shall be made under this Rule and no direction for inclusion of a name in the electoral roll of a constituency shall be given after the last date for making nomination for an election in the constituency and before the completion of that election.

21. Correction of error in roll after final publication:-

If the Electoral Registration Officer for Constituency on an application made to him or in his own motion, is satisfied after such inquiry as he thinks fit, that any entry, in electoral roll of the constituency is erroneous or defective in any particular, the Electoral Registration Officer may, subject to such general or special direction as may be given by the State Election Commissioner, take such action as is necessary to remove the defects.

Provided that no amendment shall be made under this Rule and no direction for inclusion of a name or deletion of name shall be given after the last date for making nomination for an election in the constituency and before the completion of that election.

22. Appeal :-

- (1) Every appeal shall lie before the District Election Officer from order of the Electoral Registration Officer made under rule.
- (2) Every appeal under this Rule shall be ----
 - (a) in the form of memorandum signed by the applicant,
 - (b) accompanied by a certified copy of the order appealed from:
 - (c) presented to the District Election Officer within a period of seven days from the date of the order appealed from, and
 - (d) accompanied by a fee of Rs 2/- only in cash or money order receipt showing remittance of the fee.

(3) The District Election Officer may call for the records and after hearing the parties may either allow or reject the appeal.

Provided that the District Election Officer shall not make any order for amendment of the electoral roll or make any direction for inclusion a name in or deletion of a name from the electoral roll after the last date for making a nomination for an election in the Constituency and before the completion of the election.

23. Jurisdiction of Civil Courts barred :-

No Civil Court shall have jurisdiction---

- (a) to entertain or adjudicate upon any question whether any person is or is not entitled to be registered as an elector in an electoral roll for a constituency of the Village Committee, or
- (b) to question the eligibility of any action taken by, or under the authority of the Electoral Registration Officer or of any decision given by any authority appointed under these Rules for the preparation of any such electoral roll.
